- II. Property Report: Property & Operations Manager Jennifer Smith provided a current Property Report on projects.

- **III. 2023 Budget Review** The 2023 Budget was produced by Jennifer Smith of Slatter Management and presented to the board. The board reviewed the 2022 Budget Vs. Actual in the Operating Income. The 2023 Budget proposes a 10% increase in homeowner dues based on:
 - a. Increased Fixed Contracts for Landscaping
 - c. Vendors increased costs due to supplies, gas, and labor.
 - d. As assets of the Association age maintenance of these items will increase.
 - e. Tree Removal continues to increase as trees age and weather is unpredictable.
 - f. Insurance policy increased by 15% due to the overall rate increases with policies.
 - g. The Association has not had an increase in dues since 2017.
 - Motion to approve the 2023 Budget was made by Tom Weiss
 - Unanimous to approve

Being that there is no Unfinished Business to discuss the board moved into Executive Session.
